WHEREAS, the members of these organizations have worked diligently and selflessly to honor the memory of fellow veterans killed in past wars and military conflicts; and

WHEREAS, their hard work and dedication has resulted in the renaming of the football field at Blue Streaks Memorial Stadium to Dick Hamblin Field; and

WHEREAS, Richard Alan Hamblin was a 1966 graduate of Madison Memorial High School and entered the Marine Corp to serve his Country where he obtained the rank of Private First Class while serving in Southeast Asia; and

WHEREAS, on May 27, 2014 the Madison Local Board of Education passed a resolution officially dedicating and naming the football field Dick Hamblin Field; and

WHEREAS, the dedicated efforts of the VFW Post 8548, American Legion Post 112, Hamblin Committee members Don Wickert, Bill Uehlinger, Gary Radatz, Al Mantey, Tom Izzarelli, Jon Gramoy, Mike J. Evangelista, Gretchen Burns, and Tommy Norman have been recognized for their countless hours of work to keeping the memory of Richard Alan Hamblin.

NOW THEREFORE BE IT RESOLVED that the Madison Local Board of Education appreciates the hours of community service that went into preserving the name Dick Hamblin Field at Blue Streaks Memorial Stadium and an official copy of this resolution be presented to Veterans of Foreign Wars Post 8548, Jay Wilson Post 112 of the American Legion and to the Hamblin Committee on behalf of the Board.

A RESOLUTION SUPPORTING THE MOVING OF THE NAME RICHARD ALAN HAMBLIN FROM THE FORMER MADISON MEMORIAL HIGH SCHOOL LOCATION (92 EAST MAIN STREET) TO THE CURRENT MADISON HIGH SCHOOL LOCATION (3100 BURNS ROAD)

WHEREAS, the Madison Local Board of Education honors the memory of Richard Alan Hamblin, born on May 5, 1947 in Madison, Ohio; and

WHEREAS, Richard Alan Hamblin grew up on his family farm on Dayton Road in Madison, Ohio; and

WHEREAS, Richard Alan Hamblin attended Madison Memorial High School, graduating in 1966. He was a tackle on the Madison Memorial High School Varsity Football Team as a sophomore and also was a heavyweight wrestler for the Madison Memorial High School Wrestling Team; and

WHEREAS, Richard Alan Hamblin entered the Marine Corp to serve his Country after graduating from Madison Memorial High School and he obtained the rank of Private First Class while serving in Southeast Asia; and

WHEREAS, on September 21, 1967, during a mission in the Quang Tri Province, he and his platoon were ambushed and he along with additional Marines were killed, paying the ultimate price to their Country; and

WHEREAS, Marine PFC Richard Alan Hamblin is interred at the Mentor Municipal Cemetery in Mentor, Ohio and is also remembered on the Vietnam Wall in Washington, D.C. on panel 26 E.102.

NOW THEREFORE BE IT RESOLVED that the Madison Local Board of Education on its own behalf hereby supports the name of PFC Richard Alan Hamblin be properly moved from the former location of Madison Memorial High School (92 East Main Street) to the current Blue Streaks Memorial Stadium (3100 Burns Road) in an effort to keep the memory of Richard Alan Hamblin's sacrifice for his School, Community, State and Nation alive and in our hearts.


